PANTARHIT® RSM 130 retards the initial and final setting of annular grout mixes and allows a purposeful extension of workability time. Additionally, the special formulation of the powerful admixture is able to provide a stabilising effect.

These features enable an extended storability of the annular grout in the pumping lines and grout agitator tanks on the TBM.

The application of PANTARHIT® RSM 130 enables increasing the compressive, tensile and flexural strength of annular grout mixes

The special formulation of PANTARHIT® RSM 130 allows the application of the product as conditioning admixture in one or two component grouting systems.

The maintenance of workability using PANTARHIT® RSM 130 (up to 72 hours after batching) minimize risks of choking pipelines and grout cars.

DOSAGE

Due to the different compositions of annular grout mixes, the necessary dosage quantity varies and needs to be determined in field trials.
